

PATRIOT ABOVE GROUND 25-YEAR LIMITED WARRANTY

The manufacturer warrants the vinyl liner to be a product of the finest workmanship. The manufacturer agrees at its option to replace or repair, exclusive of installation, labor charges, cost of replacement water or chemicals, F.O.B. its factory, any liner which separates at its seam within twenty (20) years prorated from the date of original purchase. If replacement or repair is required, the charge to the original consumer purchaser shall be first year, no charge (excluding freight). After the first year, the same will be supplied or repaired, at the manufacturers option, upon payment of a charge in accordance with the then retail selling price. The following schedule sets forth the percentage of retail price.
