



ARCTIC ARMOR SAFETY COVER SYSTEM

TWELVE - YEAR LIMITED WARRANTY, TWO YEARS FULL

The Manufacturer warrants to the original purchaser of the Arctic Armor Safety Cover System that the Company, at its option will repair free of charge or replace any component which, to our satisfaction, proves defective either in workmanship or material, within (2) years of purchase. The prorated basis for cover replacement is as follows:

The customer shall pay the list price at the date of claim, less 1/120 of the price for each full month remaining in the warranty period. Freight charges for repairs or replacements to be paid by the consumer.

Arctic Armor Safety Covers that have been improperly installed, altered, abused, subject to accident or used during the snow season with the pool water more than 18 inches below the pool coping, are specifically excluded from this warranty.

Although any warranties implied are limited to the twelve (12) year period after the date sold to the original purchaser, some states and/or provinces do not allow limitations on the length of the time of an implied warranty. Therefore, the above may not apply in such states and/or provinces. Any claimant under this warranty has specific legal rights and the provisions in the warranty are neither a modification nor subtractions, but rather, an addition to the statutory warranties and other rights and remedies contained in the applicable state or provincial legislation.

Manufacturer will not be liable for any incidental or consequential damages resulting from any defects in workmanship or material. Some states and/or provinces do not allow the exclusion or limitation of incidental or consequential damages, therefore the foregoing limitation or exclusion may not apply.

FIFTEEN - YEAR LIMITED WARRANTY, THREE YEARS FULL

The manufacturer warrants to the original purchaser of the Arctic Armor Gold Safety Cover System that the Company, at its option will repair free of charge or replace any component which, to our satisfaction, proves defective either in workmanship or material, within (3) years of purchase. Cover has a fifteen (15) year warranty on material degradation.

The customer will receive the following credit towards the purchase of a new safety cover.

Year 1 - 3: Full Coverage - The company, at our option, will replace or repair any defect in material or workmanship.

Year 4: 70% of current retail selling price	Year 8: 50% of current retail selling price	Year 12: 20% of current retail selling price
Year 5: 65% of current retail selling price	Year 9: 45% of current retail selling price	Year 13: 15% of current retail selling price
Year 6: 60% of current retail selling price	Year 10: 40% of current retail selling price	Year 14: 10% of current retail selling price
Year 7: 55% of current retail selling price	Year 11: 30% of current retail selling price	Year 15: 5% of current retail selling price
